- NYSDOT Master Plan <u>Survey Link</u>
 J. Yonkoski informed the committee that NYSDOT was in the process of updated their Master Plan and encouraged member to participate by take their survey.
- Bike/Ped Counter Update S. Reigle provided an update of the new bicycle and pedestrian counters installed as part of the 434 Greenway project, including the number of users for the month of August.
- Bridge Pedal Recap S. Reigle discussed the recent Binghamton Bridge Pedal which attracted over 90 riders this year.
- Pavement Ratings Road and Trail

J. Yonkoski informed the committee that BMTS was in the process of conducting our annual roadway pavement dating and that pavement scores would be provided to them in the coming weeks. She also explained that trail ratings, which is on a two year cycle, would also be conducting this fall.

J. Yonkoski informed the committee that consultants with be installing temporary traffic counting equipment at primarily signalized intersections throughout the area for our annual traffic count program.
