Scott thought it may be beneficial to post the reports on the BMTS website. Susan will ask for Region 9 approval before any reports are posted. TRG Trail Network Guide: Scott shared the latest edits on the Trail Network Guide. The committee commented that bike parking facilities (at least the Water St. Parking Garage) should be noted on the map. It was recommended once again to obtain photos that show people using the trails and to change the cover's bridge photo to a local bridge. Friends of the Two Rivers Greenway (TRG) Group – Scott shared that Mike Haas is heading up a 434 Greenway Cleanup Afternoon before the end of October. Once a date & time are determined, Scott will email a notice to the Committee. Discussion of the Traffic Signal Blue Light: Steven Bard shared his experience in Portland, OR where blue lights have been installed near traffic signal heads with signs to explain that the lit blue light informs cyclists that they have been detected by the traffic Signal. The blue lights are typically installed on roadway corridors with heavier motor vehicle traffic.
